The winners for the 2001 IADR Distinguished Scientist Awards were announced, and Alan G. Hannum received the award for Research in Prosthodontics and Implants. Ron Ettinger, who has been a significant contributor to the Prosthodontic Group was also recognized as the recipient of the Distinguished Scientist Award for Geriatric Oral Research. Congratulations to both award recipients for their significant contributions.

Annual Meetings

Both the AADR meeting in Chicago (registration of 3,326 and 1,923 abstracts) and the IADR meeting in Chiba (registration of 3,671 and 2,167 abstracts) were well attended. The IADR meeting was the best attended IADR-only meeting, and had participants from 62 countries. For the AADR meeting, 630 of the presentations were scheduled in oral and oral/poster sessions, 1,272 posters were presented in 123 sessions, there were 24 Lunch and Learning sessions, 17 symposia and 3 Plenary Session lectures. The IADR meeting included 244 total sessions with 844 oral/discussion presentations, 1,323 poster papers, two hands-on workshops, 22 symposia and 2 Plenary Session lectures.

Future Meetings

Last year, San Francisco was approved as the 2006 AADR meeting site. However, due to scheduling conflicts and the ADEA decision to go to Denver, the 2006 meeting was changed to Denver. The 2003 and 2006 IADR meeting sites were reversed, with Goteburg, Sweden becoming the 2003 site and Jerusalem, Israel the 2006 site. Brisbane, Australia was chosen as the site for the 2008 IADR meeting.

Finances

Overall, the financial outlook is good for both IADR and AADR organizations due to the extensive portfolio and the profit made by the Journal of Dental Research. At the time of the meeting, assets were approximately \$7 million. However, a large portion of these assets are in stocks, which have suffered a significant reduction in return. It was pointed out that having a loss of income from an annual meeting is devastating to the budget, and plays a significant role in selecting meeting sites. Aggressive action was taken to improve the financial outcome of the Chiba meeting, which should at least break even, if not show a profit. Central office continues to run at a \$70,000-\$100,000 loss, prompting a request for a dues increase of \$5. However, even with the dues increase, there will still be a projected operating cost deficit.

Registration fees for the joint annual meeting in San Diego were approved. Total fee will be \$300, with \$25 of the fee being earmarked for the dividend to be paid to participating Divisions. The IADR Council agreed in principle that the minimum meeting dividend should be \$1,000 for each Division with members attending the IADR meeting. However, the AADR has not agreed to this change in the Memorandum of Understanding.

DETAILED REPORTS FROM THE CHIBA BUSINESS MEETING

Councilor Report - Neal Garrett

The AADR Council meeting was held on Wednesday, March 7, 2001 in the Hyatt Hotel in Chicago, IL, and the IADR Council Meeting was held Wednesday, June 27, 2001 in the Makuhari Messe Convention Center, Chiba, Japan. Your Councilor attended both meetings.

The following election results were announced and it was noted that there was a continued increase in online voting, with 75% of the IADR votes and 65% of the AADR votes being cast online. However, overall voting was only 30% for the AADR and 24% for the IADR membership.

allocation of \$40,000 for the period from 2002-2004.

Journals

The Journal of Dental Research continues to increase in health and recognition, with the highest scientific impact factor (4.6) of any dental journal. Currently, the acceptance rate is 25.2% with approximately 450 papers per year submitted. Web-based publishing continues to be developed. Continued effort has resulted in reducing publication time and increasing the total number of articles published. Student subscription rates were increased from \$16 to \$25, along with increases in institutional and non-member subscriptions.

Due to continued losses of around \$20,000, a significant dues increase was recommended for Critical Reviews in Oral Biology and Medicine. However, it is not likely that the dues increase will be sufficient to get the journal to a break-even point.

Special Care in Dentistry increased page charges to balance the budget by 2004.

New Business

Recommendations from the Task Force on Divisions on the minimum size for a Division and increased representation for Scientific Groups were approved. This will have an impact on our Pros Group representation on the Council, with an increase from 1 Councilor from the 28 Scientific Groups having a Council vote, to 5 Council votes for the 28 groups. The 28 groups will probably be divided into 5 constituency groups and the voting seat will rotate among the groups in each constituency. However, the method for sharing the votes among the 28 Scientific Groups has not been finalized at this time.

New IADR Sections were established in Costa Rica and Kuwait.

The IADR Constitution and Bylaws had various minor updates approved, and the language was included to permit the formation of Federations. Discussion has already occurred for a Pan European Federation and a Pan Asian-Pacific Federation, with 5 regional federations to be ultimately developed.

The Joint Exhibits Committee was eliminated.

The Frechette New Investigator award was established by the Prosthodontic Group to promote the future of prosthodontic research and honor the memory of Arthur R. Frechette, the Prosthodontist and commanding officer of the Navy Dental School in Bethesda, who served as Secretary-Treasurer of the IADR from 1968 to 1977. Dr. Frechette passed away November 15, 1990.

There were twelve submissions for the Frechette New Investigator award this year. Past presidents of the Prosthodontic Group, Nancy Chaffee, Ron Ettinger and Neal Garrett, evaluated the abstracts and selected the three finalists for inclusion in the Oral Session on Wednesday, June 27. Presentations were made by Drs. M. Nishimura (Expression of Proteoglycans of Osteoblastic Cells Grown on Titanium), W. Oh (Effect of Connector Design on Fracture Resistance of All-ceramic Fixed Partial Dentures), and D. Shin (Effects of TiN Coating on

Adhesiveness of Bone-forming Cells). All finalists are congratulated on their diligent work to produce both a manuscript and presentation for the competition. After much deliberation by the judges, The Frechette New Investigator Award was presented to Dr. Won-suck Oh from the University of Florida, for his study evaluating the magnitude and sensitivity of connector design on the fracture resistance of all-ceramic FPDs.

We would like to recognize and extend our most sincere thanks to the Whip-Mix Corporation for their generosity and continued support of this award.

The group's reception, immediately following the business meeting, continues to be a popular event. Thanks to a continuing two-year effort by Dr. Angus Walls, chair of the Bylaws Committee, the new bylaws are nearly ready for final consideration and acceptance by the members.
